Doris Ann Faddis Kirouac, 82, of Knoxville, Tennessee, and a longtime resident of Duluth, Georgia, passed peacefully into the arms of her Lord and Savior on April 27, 2025, with her devoted husband, Lou Kirouac, by her side and surrounded by the love of their family and friends.

Born in Knoxville on April 15, 1943, to Herman Riley Faddis and Mary Estelle Phillips Faddis, Doris was the second youngest of eight children and one of seven girls.
