Into hour two, he finally turned to an obviously frustrated Doug and asked him to describe the work and if there were transferable skills the woman had from the work. Without hesitating, Doug's answer was blunt and to the point, "it's sheltered work for God's sakes, there are no transferable skills from being an assistant dishwasher." The hearing ended five minutes later.
