Jimmie Eldridge Baggett, Jr., 60, passed away on Monday, December 19, 2016 in Lawrenceville. Jimmie was a veteran of the United States Army and spent much of his life in law enforcement, first as a police officer and detective and later, as an assistant district attorney. After serving in the United States Army Military Police Corps, Jimmie worked with the University of Georgia Police Department, the Clarke County Police Department and the Barrow County Sheriff's Department. Jimmie received his undergraduate degree from the University of Georgia and later graduated from the Georgia State University of Law. Following his graduation from law school, Jimmie embarked on his career as a prosecutor, first with the Barrow County District Attorney and then with the Gwinnett County District Attorney's office. Jimmie was an avid scuba diver and instructor, having achieved many certifications, including a divemaster instructor. Jimmie was a talented chef and enjoyed cooking for his family and friends while telling stories from his years as a police officer and prosecutor. He was preceded in death by his parents, Jimmie Baggett, Sr. and Mamie Henrietta Baggett. Survivors include his wife, Lisa Baggett, his step-daughter, Amanda Graham; sister Brenda Willis of Little Rock, Arkansas and Darlene (Bill) Ream of New Port Richey, Florida; a half-sister Maria (Omar) Fernandez of Kennesaw, Georgia, step-siblings Robert (Janet) Mendez of Portsmouth, Virginia, Patti (Robert) Cagle of Lawrenceville, Georgia, Miryam (Olaf) Halvorssen of Miami, Florida, his two beloved chocolate labs Annie and Charlie, and many friends and colleagues.
