Susan Virginia Johnson Garzon, 53, of Buford, GA passed away peacefully, April 7, 2014, after a long fight with pancreatic cancer. Susan was born in Americus, GA and attended Americus High, graduating in 1979 and then attending DeKalb Junior College in Atlanta where she received her Associates Degree in Business. After graduation she worked for Georgia Tech University in the School Bookstore. Susan then became employed by the Blue Haven Pool Company where she began a thirty-two year career of designing, building and remodeling swimming pools. Susan and Jorge Garzon were married in 1987 and had a son, Staff Sargent Anthony James Garzon. In 1987 Sylvan Pools recruited Susan to be their new construction and scheduling supervisor; Howard Wertman, President of Sylvan Pools greatly admired Susan's supervisory abilities in managing an active construction schedule. In 2000 Susan moved to Orange City, FL to consolidate Pools by Anthony into Sylvan Pools corporate structure. After two years in Florida Susan opened Sweetwater Pool Solutions with her partner Steve Bennett, designing new pools and remodeling pools. She was one of the few women in the state of Florida to hold a swimming pool contractors' license. Susan is remembered in the pool industry as the person who was able to coordinate and remember the items that the salesmen forgot. Fighting Pancreatic Cancer for the last two years has been Susan's toughest job. Her kind manner and courage will be sorely missed by all who had the pleasure of knowing her.
